Important Note: The school has adopted Distance Learning Programme (DLP) at the start of the Academic Year 2020-21 and will continue until June 2020 following the KHDA mandate closing all educational institutions during this period as a measure taken to control the spread of COVID 19. This policy is designed for the regular school set-up and will also be integrated during the DLP.

MIDDLE & SENIOR GRADES ASSESSMENT POLICY

The assessment structure and examination pattern for class VI-IX will be similar to that of class X. This structure will bring uniformity in the system of assessment and examination for classes IX & X in all the CBSE affiliated schools. To increase the confidence in the students to start preparing for class X Board examination when they join the Middle School in class VI, as per the CBSE guidelines, TIAD has decided to implement the uniform system of assessment, examination pattern and issue of report cards for classes VI to VIII also on the similar pattern. The Assessment policy for classes VI -VIII has been designed on Term Assessment basis with gradual increase in the learning assessment as the students move forward. This would prepare the students to cover the whole syllabus of the academic year and face the challenge of class X Board examination, and would thus, ensure the 'quality of education'.
Scholastic Area: The assessment structure and examination for classes VI to VIII comprises of two terms i.e. Term-1 and 2 as explained below:

Grade 6 to 8

Term 1	20% [10% written + 5% Notebook (NB) + 5% SE] Half Yearly

Term 2	60% [50% written + 5% NB + 5% SE] Annual

Grades 9 & 10

The assessment pattern in Grades 9 & 10 will be as per CBSE guidelines. As per this, the total marks for each subject will be 100. The student has to secure an overall 33% marks in all CBSE subjects in the final results for promotion to the next grade.

The Internal Assessment will comprise of Periodic tests, Portfolio submission, Subject Enrichment and Art Integration activities.

UAE NATIONAL AGENDA


